## Welcome 2020-2022 APPA President Godehard Oepen, MD, PhD, DLFAPA

Because of the cancellation of APPA's Spring Conference, the annual business meeting was postponed and subsequently conducted via Zoom on Sept. 9.

Taking office as president is **Godehard Oepen, MD, PhD, DLFAPA**. Dr. Oepen was born and raised in West-Germany. He studied medicine in Marburg, Fribourg/Switzerland, and Freiburg. After his term in the military, he completed residency training in neurology and obtained a PhD in clinical neurophysiology. He then completed a second residency training in psychiatry at the Albert Ludwigs University in Freiburg, Germany, where he then served as senior clinician and associate professor.



In 1989, Dr. Oepen continued his research and clinical activities in Boston at Harvard University, where he underwent another required residency training in American psychiatry at McLean Hospital/Harvard Medical School.

His more than 110 articles, book chapters and three edited books cover a wide range of topics including Huntington's Disease, Parkinson's Disease, MS, Schizophrenia, Bipolar Disorder, Borderline Personality Disorder, Psychopharmacology, and Philosophical Issues in Psychiatry.

After four years at the Bedford VA Hospital and two years as medical director of the Harvard North Shore Geriatric Psychiatry Program in Salem, Mass., Dr. Oepen joined Alabama Psychiatric Services in 1999 and until its closing in Feb. 2015 was assistant medical director for Clinical Services and Education. While there he was coordinator of APS' continuing medical education program. In March 2015 Dr. Oepen joined Grayson & Associates in their Riverchase office providing inpatient care at St. Vincent's East.





**APPA requests support for 'Healthcare Workforce Resilience Act'**

In a May letter to U.S. Congressmen and House Members, APPA 1998-2020 President J. Luke Engeriser, MD, DFAPA, urged support of S. 3599, known as the Healthcare Workforce Resilience Act. The legislation addresses the shortage of physicians and nurses during the nation's COVID-19 pandemic and will enhance the healthcare workforce.

Specifically, the bill authorizes the recapturing of 15,000 unused immigrant visas for physicians as well as 25,000 visas for nurses. The bill further allows for the issuing of visas for the immediate families of these physicians and nurses and not have those visas count toward the 40,000 limit.



**Michael D. Banov MD**, is medical director of PsychAtlanta and PsychAtlanta Research Center in Atlanta, Ga., and is an assistant clinical professor of psychiatry at the Medical College of Georgia.

Dr. Banov received his medical degree from Emory School of Medicine and completed his psychiatry training at McLean-Mass General Hospital through the Harvard Medical School Residency Program. He was chief resident of the psychotic disorders program and was given a teaching faculty appointment at Harvard Medical School before moving back to Georgia.

Dr. Banov has conducted more than 100 clinical research studies with new and existing compounds in the management of acute and chronic psychiatric conditions.

**Nancy Bishop, BS**, is the State Pharmacy Director at the Alabama Department of Public Health and is the director of the Prescription Drug Monitoring Program (PDMP).

She is a member of the Alabama Pharmacist Association and the American Pharmacist Association.



**Gabrielle A. Carlson, MD**, is a professor of psychiatry and pediatrics at State University of New York at Stony Brook. She is the founder and former director of their

Division of Child and Adolescent Psychiatry.

She earned her medical degree from Cornell University Medical College and completed training at Washington University in St. Louis, and the National Institutes of Mental Health. She

completed a fellowship in child and adolescent psychiatry at UCLA where she subsequently taught on the faculty.

**Marco Del Giudice, PhD**, is associate professor of psychology at the University of New Mexico. He earned his PhD in cognitive science from the University of

Turin, Torino, Italy.

His work explores a broad range of topics at the intersection of human behavior, evolution, and development.

He has published more than 90 papers and chapters, and won the 2016 Early Career Award of the Human Behavior and Evolution Society.



**Andrew Friede, MD, MPH**, practices preventive medicine at Grayson & Associates in Birmingham.

He earned his medical degree at Johns Hopkins and completed preventive medicine residency and MPH at Harvard.

Dr. Friede began his career at the Centers for Disease Control and Prevention as a medical epidemiologist researching maternal and child health issues.



**Philip Muskin, MD, MA, DLFAPA**, is professor of psychiatry at Columbia University Medical Center and a clinical supervisor, C-L clinician and private

practitioner of psychiatry and psychoanalysis.

He is a graduate of Cornell University, the Graduate Faculty of the New School for Social Research, New York Medical College (AOA), and the Columbia University Psychoanalytic Center.

He has published numerous articles, books, and chapters on topics including the role of religiosity in DNR decisions, the psychodynamics of physician-assisted suicide, and decision-making capacity of medically ill patients.



**Praveen Narahari, MD, MS**, is assistant medical director for AltaPointe Health Systems.

He earned his medical degree from N.T.R. University of Health

Sciences - Kakatiya Medical College, Warangal, India. He also obtained a master's degree in community nutrition from Eastern Kentucky University.

Before beginning his residency in adult psychiatry at the University of South Alabama he volunteered as research assistant at the University of Louisville, Department of Psychiatry.

He served as chief resident of psychiatry during his PGY 4 year and received the Red Sash Award from the USA medical student class of 2015, 2016 and 2017. He received Faculty Teacher of the Year award from residents in 2018.

Dr. Narahari's special interests are in the area of biological psychiatry, community psychiatry and psychopharmacology.

## APA Presidential Task Force to address structural racism throughout psychiatry

In July, the American Psychiatric Association (APA) announced the creation of a Presidential Task Force to Address Structural Racism Throughout Psychiatry. The Task Force was initially described at an APA Town Hall on June 15 amidst rising calls from psychiatrists for action on racism.

Focusing on organized psychiatry, psychiatrists, psychiatric trainees, psychiatric patients, and others who work to serve psychiatric patients, the Task Force is initially charged with:

1. Providing education and resources on APA's and psychiatry's history regarding structural racism;
2. Explaining the current impact of structural racism on the mental health of our patients and colleagues;
3. Developing achievable and actionable recommendations for change to eliminate structural racism in the APA and psychiatry now and in the future;
4. Providing reports with specific recommendations for achievable actions to the APA Board of Trustees at each of its meetings through May 2021; and
5. Monitoring the implementation of tasks 1-4.

Cheryl D. Wills, MD, associate professor of psychiatry at Case Western Reserve University (Ohio), and APA Area 4 Board of Trustees Member, is the chair of the Task Force.

"The history of the APA, going back to its very roots in the 1700s, is scarred with structural racism and racist ideas," said APA President Jeffrey Geller, MD, MPH. "While efforts have occurred over the years to rectify this problem, particularly by Black psychiatrists, as a field and organization we still have a very long way to go. I believe in this moment, when all Americans are seeing the murders and trauma of many Black Americans, as well as an upswell of activism and change, we hope all our members will work with the Task Force to bring about actions that will make a difference for our organization and field with positive ripple effects far beyond." 🌍

## APPA speaks out on systemic racism

APPA recognizes and is committed to confronting racism and racial inequalities within our society and the healthcare system. APPA further recognizes the need to end systemic racism in our country and to work toward a better, fairer, and more just society.

Worsening inequities, unequal access to care, and the racial disparities of psychiatrists all have roots in systemic racism and must be confronted.

Tremendous work needs to be done to ensure that everyone has the opportunity, resources, and conditions to achieve optimal mental health.

### The Alabama Psychiatric Physicians Association:

- Opposes all forms of racism;
- Considers racism a public health crisis and a threat to public health;
- Understands the elimination of health disparities will not be achieved without first acknowledging the contributions of all races to health and social inequalities;
- Understands that we have a responsibility to actively work to eliminate discriminatory policies and practices across all of healthcare;
- Supports ending racial discrimination in mental health care and the equitable access to quality services; and
- Encourages all psychiatrists to be advocates for justice. 🌍

## Survey: Alabama medical practices hit hard by COVID-19

In just a few months, the coronavirus pandemic changed the way we function as a society and fundamentally altered our healthcare delivery system. It has exacerbated weaknesses in the infrastructure of health care and exposed limitations in current policies at a time when costs are rising and access to care is dwindling.

The Medical Association of the State of Alabama conducted a survey to determine the impact of COVID-19 on medical practices and care delivery. The survey identified several key findings:

- Patient volume is down leading to concerns that Alabamians are not going to their physician for routine care;
- More than 70% of respondents said COVID-19 has had a severe impact on practice finances, causing layoffs and furloughs and limiting access to care;
- More than 71% said they're likely to continue providing telemedicine if insurers continue covering those services; and
- More than 71% are concerned about the potential liability from lack of PPE and patients canceling or delaying procedures and other medical care.

In light of the findings of the survey, the Medical Association is recommending several public policy proposals:

- Allocate state stimulus funds to reimburse practices for COVID-19 related expenses;
- Expand testing, PPE, and cleaning supply availability;
- Continue coverage of telemedicine by insurers at existing rates; and
- Enact "safe harbor" legislation to provide liability protections to health care providers.
